AGREEMENT FOR SUPPLY OF GOODS/MATERIALS PURSUANT TO CREDIT

This Agreement is made by and between Allied Demolition, Inc (Allied) and the customer (hereinafter "Customer") identified herein as represented by the Customer's or Customer's authorized representative's signature hereto. Customer has requested that Allied provide goods or materials under a credit agreement in which Customer will pay Allied for the goods or materials provided pursuant to the terms of this Agreement, which requires a personal guaranty duly executed by Customer or Customer's authorized representative at the time of such Agreement. The parties agree that this Agreement is supported by adequate mutual consideration and obligations so as to allow Customer to receive goods or materials without immediate payment to Allied in return for payment under the terms of this Agreement.

The terms of payment per this Agreement are net 10 prox. Customer agrees to pay a service charge of 1 ¾% per month or 21% per annum, on any and all amounts not paid in full by the 27th of the month in which payment is due. Allied may, at its sole option, turn any account 60 days past due to a collection agency or attorney for collection, and Customer agrees to pay reasonable collection costs, court costs, expenses and attorney fees.

The quantity and pricing of goods or material supplied by Allied to Customer under this Agreement shall be conclusively evidenced by the pre-established agreement based on publication or negotiation between Allied and Customer.

ALLIED AND CUSTOMER AGREE THAT ALL DISPUTES AS TO THE AMOUNT OF A WEIGHT TICKET OR AN INVOICE SHALL BE SUBMITTED TO ALLIED OR ITS DESIGNATED AGENT IN WRITING WITHIN 20 DAYS OF THE DATE OF THE INVOICE. IF CUSTOMER DOES NOT DISPUTE THE INVOICE WITHIN (20) DAYS OF THE DATE OF INVOICE, THEN CUSTOMER WAIVES ANY FURTHER RIGHT TO DISPUTE THE INVOICE. CUSTOMER WARRANTS, REPRESENTS, AND ACKNOWLEDGES THAT CUSTOMER HAS THE FINANCIAL ABILITY TO PAY FOR ALL FEES, COSTS, AND EXPENSES CONTEMPLATED BY THIS AGREEMENT.

PERSONAL GUARANTY

For valuable consideration, the sufficiency and receipt of which is hereby acknowledged, and in order to induce **Allied Recycled Aggregates**, hereafter referred to as "**Allied**", in its discretion at any time and from time to time, to sell and deliver any goods made, or to be made, or to extend credit, directly or indirectly, to or for the account of

_____, hereinafter referred to as "**Customer**", the undersigned, hereinafter referred to as "**Guarantors**", jointly and severally, guarantee to **Allied**, its successors and assigns, to promptly pay the full amount of any and all **Indebtedness**, including but not limited to amounts that may, at any time, be owed to **Allied** on invoice, or otherwise, by the **Customer**, hereafter referred to as "**Indebtedness**", incurred pursuant to **Agreement For Supply Of Goods/Materials Pursuant To Credit**, hereinafter referred to as **Agreement** and agree to promptly pay any and all costs and expenses, including but not limited to, attorney's fees and court costs, incurred by **Allied** in any attempt to collect **Indebtedness** owed to **Allied** by **Customer** or in the enforcement of this **Guaranty**.

This is an unconditional and continuing **Guaranty** and the liability and obligations of the **Guarantors** herein shall be primary and in any right action which shall accrue to **Allied** for any and all **Indebtedness**, **Allied**, at its option, proceed against the **Guarantors** without having commenced any action, or having obtained any judgment against the **Customer**. The obligation of the **Guarantors** covers all existing and future **Indebtedness**, arising out of or connection with the **Agreement** and shall: 1) continue in full force, notwithstanding the acceptance by **Allied** of any settlement or compromise or consent thereto; 2) be and continue effective notwithstanding any legal disability of the **Customer** to incur **Indebtedness** or obligations to **Allied** in whole or in part; and 3) shall be effective regardless of the solvency or insolvency of the **Customer** at any time, the extension or modification of the **Indebtedness** by operation of law, or the subsequent incorporation, reorganization, merger or consolidation of the **Customer**, or any other change in the composition or nature of the **Customer**.

The **Guarantors** waive any and all notice of the acceptance of this **Guaranty**, of the creation, including renewal or extension of any or all **Indebtedness** and of any and all defaults in payment of any or all of the **Indebtedness** and waive presentment, demand, protest and notice of dishonor, as to any or all **Indebtedness**. This **Guaranty** shall bind the respective agents, officers, directors, managers, shareholders, members, if any, heirs, administrators, personal representatives, successors and assigns of the **Guarantors**, and all of **Allied** rights hereunder shall be cumulative and not exclusive of one another.

Allied's business records shall be admissible in evidence in any action or proceeding involving this **Guaranty**, and such records shall be prima facie proof of the items therein set forth, and the **Guarantors** specifically waive any and all defenses whatever which the **Customer** may have against **Allied** other than the full and timely payment of said **Indebtedness**. Each **Guarantor** further waives all defenses provided by sureties or **guarantors** at law or in equity other than the full and timely payment of said **Indebtedness**.

Termination of this **Guaranty** must be presented to **Allied** in writing stating reasons for the termination. Such termination will not release **Guarantor** for any balance outstanding at the time of termination. This termination may be basis to terminate the **Customer** accounts with **Allied**.

Nothing contained herein shall be construed as an obligation upon **Allied's** part to manufacture or sell goods or extend credit to the **Customer**, or as an obligation to continue to manufacture and sell goods or extend credit. The release of any of the **Guarantors** shall not release any other **Guarantors**. The use of the singular herein shall include the plural.
